President's Report -- Pam Schroeder reported on the following activities and thanked all the volunteers that made them happen:

- 1) <u>FCAL Newsletter</u> Vi Lamers does an excellent job editing, designing, and distributing the FCAL newsletter. Anyone interested in submitting articles or photos should do so by mid-May, so the newsletter can be ready to go out in early June.
- 2) Mole Lake Fish Hatchery Tour Larry Sommer arranged for FCAL members to tour the fish hatchery. The tour was led by Mike Pruel and attended by nearly 30 FCAL members from quite a few Forest County lakes.
- 3) <u>Kentuck Days</u> Our booth at Kentuck Days was a success. Derek Thorn (FLOW-AIS Coordinator) and a volunteer from Wild Rivers Invasive Species Coalition (WRISC) donated their time as did some FCAL members including Greg Schmitz, Clair Carty, Mark Smith, and Kathy Babcock. Bags of lead-free sinkers were distributed.
- 4) <u>Fall Forum</u> Jim Zach organized this year's Fall Forum. Forest County lake leaders shared their concerns about issues facing their lake associations. Greg Matzke (WDNR fishery biologist), Derek Thorn (FLOW-AIS coordinator), and Jean Fanin (Zoning Officer for Forest County) presented on issues relevant to our area lakes. FCAL thanks Lake Lucerne's Advancement Association for the use of its Pavilion.
- 5) Essay Contest Clair Carty organized our essay contest for 5th and 6th graders from schools in Crandon, Laona, and Wabeno. FCAL members judged the essays, and Pam Schroeder and Clair Carty presented the awards at each school's award day. The winning essays were published in local newspapers and each winner, with family, was invited to FCAL's annual dinner.

6) Environmental Days – Michelle Gobert and Lee Lamers helped organize this event for area high school students. The event was held at Veterans Park on Lake Metonga. There were thirteen volunteers who managed eight workshops through which the students rotated. Due to a scheduling conflict (Rhinelander held a Career Day for are high school students on the same day), we had a lower student turn out than usual; however, twenty students attended and had a great day learning about issues facing our area lakes.
