# **SECRETARY'S REPORT**

Motion to accept the minutes from September 20, 2024 was made by Bob Ebben, seconded by Mike Henderson. Motion to amend the minutes to change the name "Stacey" to "Laura" was made by Clair Carty, seconded by Mike Henderson. Amended minutes. Amended motion passed unanimously.

Kathy read the letter we received from Pickerel/Crane Lakes Protection & Rehabilitation District thanking us for the three donated fishing line receptacles.

**TREASURER'S REPORT** -- Bob Ebben presented the treasurer's report. Motion to accept the Treasurer's Report as presented was made by Greg Schmitz, seconded by Mike Henderson and passed unanimously.

Bob indicated that at our last meeting he said he would transfer money from our Laona State Bank account to our checking account, but because of the successful mailing done by Greg to area businesses, he did not have to do so. Thank you, Greg.

**GRANT UPDATES** – Bob is working on a grant from Visit Forest County with the help of Curt Haga. Curt recommended that FCAL become a member of Visit Forest County before sending in the application. We gave Bob permission for FCAL to join the Visit Forest County group. Greg will send Bob a photo of our lead-free sinker packaging to include in the application. Bob already has a photo of the fishing line receptacles for this purpose.

# LIAISON REPORTS

Forest County Land and Water Conservation: No report at this time.

<u>FLOW/AIS</u>: Derek Thorn reported that he recently attended the Upper Midwest Invasive Species Conference in Duluth. He especially found the presentation on treatments of zebra mussels using either CO2 or copper sulfate helpful. Another presentation he attended was on the use of ProcellaCor to treat Eurasian Milfoil.

Derek will be presenting on FLOW's Resort Owners Outreach Project at the spring Wisconsin Lakes and Rivers Convention (March 26-28 in Stevens Point). We suggested that he consider adapting this project for fishing guides and other lake user groups (e.g., fishing tournaments and Foot Stock Races).

Jim Zach brought in weed samples from Peshtigo Lakes for Derek to identify. Derek suggested that it is likely Eurasian Milfoil but it could by a hybrid – he will send the sample out for identification. When a hybrid is suspected, samples are sent to a lab in Montana for determination via DNA testing. Jim's concern is that Peshtigo Lake is loaded with non-native Milfoil, and participants for Foot Stock Races move from Peshtigo Lake to Lake Lucerne.
